

## How will alimony be determined in divorce cases?

New Delhi: The suicide of engineer Atul Subhash in Bangalore has raised many questions on the country's judicial system. After this, the Supreme Court has now determined 8 factors for deciding alimony in divorce cases. In his suicide note, Atul has accused his wife and in-laws of harassment and has also criticized the country's judicial system. Let us know what formula the court has determined. Before committing suicide, Bihar resident Atul had recorded an 80-minute video in which he accused his estranged wife Nikita Singhania and her family of filing 9 cases against him and his family to extort money. He said that

all these cases are in court and he is being given dates continuously. Frustrated by all this, he has decided to end his life. On Tuesday, the bench of Justice Vikram Nath and Justice PV Varale of the Supreme Court while giving the verdict in the divorce case of a couple named Praveen Jain and Anju Jain, has determined 8 factors for deciding the amount of alimony. The bench advised all the courts across the country to base their such orders on the factors mentioned in the verdict. In such a situation, it will be easy for the parties to decide the alimony. The Supreme Court has asked to prepare the alimony keeping in mind

the social and economic status of the husband and wife, the basic needs of the wife and children in the future, the qualification and employment of both the parties, the sources of income and assets, the standard of living of the wife while living in her in-laws' house, whether she has left her job to take care of the family, the appropriate amount for legal battle for a wife who is not working and the financial status of the husband, his earnings and other responsibilities along with the alimony.

While determining the factors for alimony, the court said, the above factors do not form any simple formula but serve as guidelines while fixing permanent alimony. The amount of alimony should be decided in such a way that the husband is not punished but a decent standard of living is ensured for the wife. The court said that no court can fix alimony with the intention of punishing. Atul and Nikita got married in 2019 through a matchmaking website. In 2020, they had a son. Atul alleges that Nikita's family often demanded lakhs of rupees from him. When he refused to give money, Nikita left the house with the child in 2021. After this, his wife and her family filed 9 cases against him and demanded Rs 3 crore to settle the matter.

## NIA raids 5 states in case related to Jaish-e-Mohammed

New Delhi: The hideouts of suspects at 19 places in Jammu and Kashmir, Assam, Maharashtra, Uttar Pradesh and Gujarat in the morning. This action was taken on the hideouts of suspects associated with the banned terrorist organization Jaish-e-Mohammed. It is alleged that these

people were involved in a conspiracy to radicalize the youth and spread terror in the country. The operation was said to be focused on efforts to counter the spread of terrorist propaganda and extremist activities. The move comes two months after the anti-terrorism agency conducted searches at several locations in five states and arrested a man named Sheikh Sultan Salah Uddin Ayubi alias Ayubi. Ayubi was detained after searches were conducted at 26 locations in the states of Assam, Maharashtra, Uttar Pradesh, Delhi and Jammu and Kashmir. The



## Lok Sabha proceedings adjourned till 2 pm due to uproar by opposition

New Delhi: The proceedings of both the houses of Parliament began at 11 am on Thursday. Before the proceedings of the House began, there was a protest from the opposition parties on the Adani issue. Leader of the House in Rajya Sabha JP Nadda raised the issue of alleged connection between American businessman George Soros and Congress MP Sonia Gandhi. After this, due to the uproar, the proceedings of the House were adjourned till 2 pm. Earlier, there was an uproar in the Rajya Sabha after a notice was given to bring a no-confidence motion against the Chairman and Vice President Jagdeep Dhankhar on Wednesday. Congress chief Mallikarjun Kharge said that the opposition was forced to introduce a no-confidence motion against Dhankhar as he is the biggest disruptor in the Upper House. Kharge said that his actions have hurt the dignity of the country. He also stressed that there is no personal fight against the Chairman of the Rajya Sabha. On Wednesday, Rajya Sabha also witnessed disruption when senior BJP leader JP Nadda demanded a discussion on the alleged Congress-George Soros connection. Today, the government has listed three bills for final consideration and passage in the Lok Sabha and Rajya Sabha. The proceedings of the Lok Sabha have been adjourned till 2 o'clock. Earlier, the

proceedings of the Rajya Sabha were also adjourned till 2 o'clock. Union Minister and BJP chief JP Nadda said, yesterday Congress President Mallikarjun Kharge made allegations against the Chairman of the Rajya Sabha. Mallikarjun Kharge is a very senior leader. He should be aware that the decision of the Chairman is final and indisputable. Making such allegations is reprehensible. This is very unfortunate. Mallikarjun Kharge was given enough opportunities to speak in Parliament. But he has said on record that he will not speak. He was also invited to the House to speak, but he refused. This shows that the Congress party's intention is not to cooperate in the

### Demand for discussion in Rajya Sabha on the statement of Allahabad High Court judge

New Delhi: The issue of the alleged controversial statement made by the Allahabad High Court judge was raised in the Rajya Sabha on Thursday. Congress MP Renuka Chaudhary demanded a discussion under Rule 267 on the statement made by the Allahabad High Court judge. However, the Chairman did not allow discussion on this topic. He said that this cannot be discussed under Rule 267. The Chairman said that the rule is very clear in this context which has been made by us. It is noteworthy that Allahabad High Court judge Justice Shekhar Kumar Yadav had made this alleged controversial statement in a program of Vishwa Hindu Parishad's legal cell held in Prayagraj recently. Congress' Renuka Chaudhary wanted to register her protest against this statement and discuss

it in the House but she was not allowed to do so. The opposition, which was demanding discussion on other issues including the Allahabad High Court judge, had also given notices under Rule 267 on many other topics but all of them were rejected. The opposition expressed its objection to this and uproar started in the House. When the opposition protested, Leader of the House and Union Minister JP Nadda said that the Chair's decision cannot be questioned in this manner.

He said that if this is done, it is a contempt of both the Chair and the House. Nadda said that Leader of the Opposition Mallikarjun Kharge condemned the Chair by holding a press conference. This shows the way to a wrong tradition and his move should be condemned.

## Pakistani balloon found near Indo-Pak border in Kathua, Jammu and Kashmir

Jammu: A Pakistani balloon was found in the fields of Lahri village located near Rajbagh police station area on the India-Pakistan international border in Kathua district. The local police seized the balloon. The balloon has the mark of PIA (Pakistan International Airlines). A police spokesperson said that after the recovery, the police has started investigating the matter. The Army has busted a terrorist hideout in Reasi district of Jammu and Kashmir and recovered a huge quantity of arms and ammunition. The National Rifles personnel achieved this success during a cordon and search operation in the Mahor forest of

Reasi district. According to officials, the items recovered include an AK rifle, three magazines filled with more than 400 rounds, two pistols, two magazines with 14 rounds and four hand grenades. Let us tell you that on Wednesday, security forces destroyed an explosive in Langate area of Kupwara district. This averted a major incident. A joint team of police and National Rifles detected a suspicious explosive object on the Baramulla-Hanwara road. The bomb disposal squad seized it and destroyed it. Security arrangements are tight in Jammu and Kashmir. Security forces are running a campaign to root out terrorist activities.

## Cold winds in Delhi break 14 years old record, temperature recorded at 4.5 degrees

New Delhi: Winter has picked up pace in Delhi. Snowfall in the mountains has increased the cold in the plains and the temperature has dropped considerably. On Thursday morning, the minimum temperature of Delhi was recorded at 4.5 degrees Celsius, 4.1 degrees below normal, which is even lower than Shimla. It broke the record of 14 years. In Himachal Pradesh's capital Shimla, the minimum temperature on Thursday morning was recorded at 5.0 degrees Celsius, 0.7 degrees below normal. The minimum temperature in Delhi on Wednesday was recorded 5 degrees below normal at 4.9 degrees Celsius, but due to continuous cold winds, it dropped by 0.4 degrees



on Thursday. The Indian Meteorological Department (IMD) has predicted that the temperature in Delhi will remain around 4 degrees Celsius for the next 3 days. After December 15, it may reach 5-6 degrees. After 14 years, the minimum temperature in Delhi has gone below 5 degrees. Cold has intensified in Delhi as well as Uttar Pradesh, Bihar,

down to 4 degrees or below. The possibility of cold wave has increased in the states of North India including Delhi. The weather department has issued a warning due to the intermittent rains in Tamil Nadu for the last few days. Schools have been closed in view of the possibility of heavy rains in Tiruvallur, Vellore, Kanchipuram, Chengalpattu, Villupuram, Cuddalore, Mayiladuthurai, Thanjavur, Ramanathapuram and Dindigul including Chennai. There is a warning of rain in Tamil Nadu and Andhra Pradesh due to the small pressure formed over the Bay of Bengal. Fishermen have been asked to stay away from the coast. Orange alert is issued in Puducherry.


## Abhijeet Infrastructure MD sentenced to 4 years

New Delhi: Rouse Avenue Court has sentenced Abhijeet Infrastructure's managing director to four years and former director to three years imprisonment in the 2005 coal block allocation scam in Jharkhand. The court has ordered a fine of Rs 30 lakh on the company. Special Judge Arun Bhardwaj gave this order. The court has sentenced Abhijeet Infrastructure's managing director Manoj Kumar Jaiswal to four years and former director Ramesh Kumar Jaiswal to three years imprisonment. The court had convicted all three on December 9. The court had convicted the company Abhijeet Infrastructure, its managing director Manoj Kumar Jaiswal and former director Ramesh Kumar Jaiswal in the case of allocation of coal blocks to Abhijeet Infrastructure in Brinda, Sisai and Meral of Jharkhand in 2005. According to the CBI, Abhijeet Infrastructure had obtained the allocation of coal blocks by conspiring with public servants. The company is accused of misrepresenting its financial position. According to the CBI, Abhijeet Infrastructure got the allocation of the coal block on the basis of fake documents related to land acquisition, purchase of machinery and financial support for running the plant. The company had submitted fake documents

of purchasing land in Hazaribagh to get the allocation of the coal block. Through fake documents, the company got a recommendation in its favour from the Steel Ministry. After which it got the allocation of the coal block. The court found that public money was lost by obtaining the allocation of coal block through fraudulent means. In this case, the CBI had registered an FIR in 2016. The CBI filed a chargesheet in 2020. In the chargesheet, the CBI had accused the company and the two accused of criminal conspiracy, cheating and fraud. In this case, 34 witnesses and 74 documents were examined.

## Controversy over the statement of actress and BJP MP Kangana Ranaut; Hearing in Agra MP-MLA court today

Agra: The case related to actress Kangana Ranaut will be heard today in the MP-MLA court of Agra district of Uttar Pradesh. The last hearing was held on November 28. The actress did not attend it. Her lawyer also did not come. On this, the court fixed the next date as December 12. The court again sent a notice to Kangana's address. In this, the actress surrounded by allegations of treason was directed to appear in court. Today the actress can appear in court or present her side through a lawyer. Senior Congress leader and advocate Ramashankar Sharma had filed a case against actress and BJP MP from Mandi, Himachal Pradesh, Kangana in the Special Judge MP-MLA Court. This case was filed on 11 September 2024 under the sections of treason and insult to the nation. It was alleged that actress Kangana Ranaut, in an interview on 26 August 2024, had called the farmers agitating against the central government as murderers and also used



Kumar Singh had given the date of December 12 in the last hearing. The court will hear this today. Senior advocate Ramashankar Sharma, plaintiff and president of Rajiv Gandhi Bar Association, says that I myself am hurt by the controversial statement of the actress. I am from a farmer family. Let us tell you that actress Kangana Ranaut had posted a video on social media platform 'X' on September 25 and said that she is taking back her words. She said that if anyone is disappointed by my statement, then I will regret it. In the video, actress Kangana is saying that, I am not only an actress but also a BJP MP. Whoever has been hurt by my statement, I am sorry for that.

## 5-year-old Aryan trapped in a 150 feet deep borewell dies, rescue efforts fail

Jaipur: All efforts to save 5-year-old Aryan, who was trapped in a 150 feet deep borewell in Dausa district of Rajasthan, failed. He died in the borewell on Wednesday night. Aryan was trapped in the borewell for the last 57 hours i.e. more than 2 days. He was being given oxygen through a pipe. He was pulled out in an unconscious state with the help of a rope at 11:45 pm on Wednesday night and was taken to the hospital, where he died. Aryan was playing outside the house on Monday, 9 December,

If you do not apply for NRC, you will not get Aadhar card

Guwahati: The Himanta Biswa government of Assam has taken a big decision regarding NRC. The Chief Minister has made it clear that it is necessary to apply for NRC. At the same time, those who have not applied for NRC will not even get Aadhar card. The Chief Minister said that this decision has been taken in the cabinet meeting. After the cabinet meeting, the Chief Minister addressed a press conference in Dispur. The Chief Minister said that the BSF, Assam Police and Tripura Police have arrested many Bangladeshis.
