# Important decision of the High Court, dismissal from job without investigation is like 'death sentence'

**Jaipur :** The Rajasthan High Court has made an important remark that dismissal from a job is like a 'death sentence' for an employee. The court stressed that no one can be fired from a job by merely issuing a show cause notice, but it is mandatory to follow a proper investigation process for this. This remark was made during the hearing on a petition filed against the dismissal of a government employee from the job. According to a Live Law report, a bench of Justice Vineet Kumar Mathur directed the reinstatement of a physical training instructor (PTI) who was dismissed without a charge sheet or disciplinary inquiry. The court clarified that the order of dismissal from service is a serious step and it should be passed only after a completely fair and proper investigation



to protect innocent persons from being punished. What is the whole matter? In fact, the petitioner PTI was dismissed from service on the basis of a mere show cause notice, accusing him of obtaining the job fraudulently. The trainer had argued in his petition that he was fired from the job without issuing any charge sheet or conducting any disciplinary inquiry, which is a violation of the principles of natural justice. The petitioner was appointed in the year 2023 and a show cause notice was issued to him in 2024. The state government did not find the reply given by the petitioner satisfactory and issued an order to terminate his services. The petitioner argued in the court that all the documents submitted by him during the recruitment process were genuine and he had not committed any

forgery. It was also said that the procedure prescribed under the Rajasthan Civil Services (Classification, Control and Appeal) Rules was not followed to take action against the petitioner. On the contrary, the state government argued that discrepancies were found in the documents submitted by the petitioner and in the preliminary investigation it was found that the job was obtained fraudulently. After hearing the arguments of both the sides, the court emphasised that no chargesheet was issued against the petitioner before

termination of service and no disciplinary enquiry was initiated. The harsh step of termination was taken only on the basis of a show cause notice. "Considering the facts and circumstances of the present case, the order of termination is like a death sentence. Therefore, it should be passed after proper enquiry to save an innocent person from being punished," the court said. The court further said, "In the opinion of this Court, the procedure adopted by the respondents (state government) is not correct. Without any enquiry, the respondents have come to the conclusion that the appointment obtained by the petitioner is on the basis of forged documents. Merely conducting a one-sided enquiry by the respondents and finding the fact that some documents have been

## Started considering the innocent son as 'white jinn's child', mother committed a big crime after getting influenced by the words of the Tantrik

**Faridabad:** A heart-wrenching case has come to light in Faridabad adjacent to Delhi. Here a woman living in Sainik Colony, under the influence of a Tantrik, threw her two-year-old innocent son into the Agra Canal on Sunday night. It is being told that the woman started considering her son as 'white jinn's child' on the advice of the Tantrik. This incident happened near the BPTP bridge on Sunday night, where the local people saw the woman throwing the child into the canal. People immediately caught the woman and informed the police. The police reached the spot and took the woman into custody. According to initial information, while being caught, the woman

kept denying throwing the child into the canal. The police and administration have launched a massive operation to search for the child. A team of fire department, State Disaster Management Force (SDRF), police and local divers are searching for the child in the Agra canal. The woman's husband Kapil Lukra, while filing a complaint with the police, said that he was married to Megha Lukra about 16 years ago and they have two children - 14-year-old daughter Manya and about two-year-old son Tanmay alias Ronik. He told that his wife Megha was in contact with a Tantrik named Mita Bhatia for a long time. According to Kapil Lukra, Tantrik Mita Bhatia

used to provoke his wife by calling son Tanmay 'white jinn's child'. The Tantrik had told Megha that this child would destroy their entire family. Megha was mentally disturbed because of these things and was under stress thinking that her son was the 'son of a white jinn'. On Sunday evening around 5 pm, Megha left the house with her son Tanmay without telling anyone. Her husband started looking for her. At around 9 pm, the police informed Kapil that a woman named Megha has been detained and she is accused of throwing her son into the canal. Hearing this, Kapil reached the BPTP police station in a panic. Local people told the police that they saw a woman trying to throw a child in her lap into the canal

on the BPTP bridge. They tried to stop the woman by making noise, but by the time they reached, the woman had thrown the child into the canal. People immediately caught the woman and informed the police by calling on Dial 112. According to the SHO of BPTP police station, on the complaint of Kapil Lukra, a case has been registered against his wife Megha Lukra and Tantrik Mita Bhatia who instigated her under murder and other related sections. The police is interrogating Megha Lukra who has been taken into custody. At the same time, police teams are continuously raiding in search of absconding Tantrik Mita Bhatia. Police is investigating every aspect of this heinous incident in depth.

Women seen hanging on the footboard of Mumbai local train, shouted - 'I am losing my hand'

**Mumbai:** The security system of the local train, called the 'lifeline' of Mumbai, has once again come under question. A very sizzling video went viral on social media. The video is going viral, in which some women are seen hanging from the gate and footboard of a moving train, risking their lives. This video shows the horrific condition of passengers traveling in Mumbai local train. It can be clearly seen in the viral video that there is a huge crowd inside the train and women are hanging outside. Some women are screaming for help. A woman can be heard saying, "My hand is slipping, come inside." But the crowd is so much that it does not seem possible to go inside. Another girl is trying to escape from the camera. It is being told that this video is of the Ladies Special train running from Kalyan, which was running 40 minutes late that day. Due to the delay in the train, a huge crowd of passengers had gathered on the platform,



due to which this deadly pushing and crowd was seen when the train arrived. After this horrific video surfaced, people on social media are constantly asking questions to the railway administration and Railway Minister Ashwini Vaishnaw about the security arrangements. This is the situation when the number of deaths due to crowd or falling in Mumbai's local trains has been quite worrying. 

## Schools in four districts of Punjab bordering Pakistan still closed

**Chandigarh:** Even after the declaration of Indo-Pak ceasefire, schools in four districts of Punjab bordering Pakistan are still closed. A senior government official said that except Gurdaspur, schools will remain closed on Tuesday as a precautionary measure in these districts of Punjab bordering Pakistan. Soon after Prime Minister Narendra Modi's address on Monday, authorities in Amritsar, Pathankot, Jalandhar and Hoshiarpur appealed to people to avoid going out unless necessary and imposed a partial blackout after receiving instructions from army officials. In Jalandhar, a surveillance drone was shot down by the armed forces on Monday evening. "I have been told that a surveillance drone was shot down by the armed forces around 9.20 pm near Mand village. A team of experts is searching for the debris," Jalandhar Deputy Commissioner Himanshu Aggarwal



said. Aggarwal later said there was no drone activity in Jalandhar after 10 pm. In a message at 10.45 pm, he advised people not to go near the debris and immediately inform the nearest police station. Hoshiarpur Deputy Commissioner Ashika Jain confirmed hearing some explosions in Dasuya area and then announced a partial blackout after receiving instructions from army officials. He said a blackout was imposed in Dasuya and Mukeria areas based on

## Greater Noida: 603 mobile phones worth Rs 2.50 crore recovered, three arrested including the driver of the company

**Greater Noida:** May 13 (RNS). The Knowledge Park police station of Greater Noida has achieved a major success and busted a gang of mobile phone thieves. The police arrested three accused and recovered 603 mobile phones worth about Rs 2 crore 50 lakh and a pistol from their possession. According to the information, the theft was committed on April 8 last month from a container carrying Vivo company's mobile phones. The accused cleverly broke the seal of the truck and transferred the cartons of mobile phones to another truck and after sealing it again, left the truck at the delivery point and fled. After this incident came to light, the company complained about this incident to the police, after which the



police started investigating the matter with the help of electronic surveillance and CCTV footage. The police raided near Jhutta railway underpass and arrested the three accused. The arrested accused also include the truck driver of Vivo company. The arrested accused were identified as Arvind Dubey, a resident of Farrukhabad, Abhishek Chauhan, a resident of Kotwali Dehat police station area of Etah district and Simran Sethi, a resident of Shyam Nagar

Extension of Tilak Nagar police station area of New Delhi. According to the police, the accused were trying to sell the stolen mobile phones in Nepal and Bangladesh. According to the police, 603 Vivo mobile phones have been recovered. The estimated price of the recovered mobile is Rs 2.50 crore. At present, the police is continuously raiding to recover the remaining stolen mobiles. This action was taken by the Knowledge Park police station.

information received from the armed forces. Normal activity was seen in the border district Amritsar but an alert was issued and a blackout was also imposed for a few hours on Monday. Sources said an IndiGo flight from Delhi to Amritsar was diverted after drone activity was seen in other parts of the state. Early in the morning, Amritsar Deputy Commissioner Sakshi Sahni wrote on 'X', "Now you may hear a small siren - indicating that the alert is over and we can resume our normal activities.
