# Muzaffarpur: Junk dealer murdered, shot outside shop

**Muzaffarpur,** A junk dealer was shot dead in Majhauliya of Muzaffarpur Sadar police station area of Bihar. After this, tension prevails in the area. The deceased has been identified as businessman Mohammad Gulab (45). The criminals committed the crime at around 8 pm on Wednesday night. The criminals shot three bullets in his head, neck and chest. It is being told that this incident happened when the businessman was sitting on his scooter after closing his shop. After this incident in the area, a large number of local people reached the spot. Gulab was immediately admitted to the hospital, where doctors declared him dead. After the incident, the angry mob



blocked the road and attacked the house of the accused Panchayat Samiti member Tufail Ahmed and set two cars and a bike on fire. The mob also tried to set Tufail's house on fire. Meanwhile, the police reached the spot and seeing the situation going out of control, used mild force

to disperse the protesters. The blockade was ended on the assurance of action against the criminals by senior police officials. The reasons behind the murder

are said to be land dispute and a fight between children in the mosque two days ago, in which Gulab was threatened. According to the police, the entire matter is being investigated thoroughly. CCTV footage is being scanned and raids are being conducted to arrest the accused and the accused will be caught soon. In view of the tense atmosphere, the police appealed to the people to maintain peace. According to the police, the body has been sent for post-mortem. However, the family of the deceased accused Tufail Ahmed, Mohammad Badal, Mohammad Aqeel, and Mohammad Chhotu of murder. The family also alleges that the police did not take action on the earlier complaint.

## Conspiracy of big attack in Delhi, UP and Gujarat failed, big disclosure about the captured Al-Qaeda terrorists

**Ahmedabad** /New Delhi, Gujarat ATS has arrested four suspected terrorists while busting an Al-Qaeda terror module in a major inter-state operation. These arrests have been made from Gujarat, Delhi and Noida. Investigation has revealed a shocking fact that this module was preparing to spoil the atmosphere in India against 'Operation Sindoor' and carry out major terror attacks in Delhi, UP and Gujarat at the behest of Pakistani Army and ISI. According to Gujarat ATS, the arrested terrorists are associated with 'Al-Qaeda in Indian Subcontinent (QAEDI).' Their main job was to incite and radicalize the youth of a particular



community through social media in favor of Pakistan against India's 'Operation Sindoor'. Investigation has revealed that this module was working in support of the Pakistani Army's 'Operation Bunyan ul Marsoos'. These terrorists had contacted the officials of Pakistani Army and ISIS several times during 'Operation Sindoor'. The terrorists were constantly sending confidential information across the border through two social media accounts of Pakistan and were getting instructions for attacks through chatting on these accounts. These terrorists used to brainwash the youth by showing jihadi videos of terrorists like Osama bin Laden and Maulana Asim Umar. The mastermind of this entire

module was Mohammad Faiz, who has been arrested from Delhi. Faiz, who was highly educated, was working as a manager in a fast food chain in Delhi. He had joined the other three terrorists with him. Terrorist Zeehan Ali, arrested from Noida, works at a mobile shop, while the two terrorists arrested from Gujarat used to work as tailors. After this major action, Gujarat ATS is now in touch with Delhi Police's Special Cell and UP ATS to reach the depth of this network. Agencies believe that after 'Operation Sindoor', these terrorists were planning to carry out a series of terrorist attacks in many places including Delhi, UP and Gujarat.

## Supreme Court's historic decision in domestic violence case, no arrests for 2 months; first the case will be sent to the Family Welfare Committee

**New Delhi,** The Supreme Court has given a historic verdict in cases related to domestic violence and dowry harassment. Banning immediate arrest in cases registered under Section 498 of the Indian Penal Code, the court has said that now after the FIR is registered, the police will not arrest the accused (husband or his relatives) for two months. This period of two months has been called the peace period. The Supreme Court on Tuesday ordered the implementation of two-year-old guidelines of the Allahabad High Court across the country. This decision was given by a bench of



Justice B.R. Gavai and Justice Augustine George Masih while hearing a case related to a female DGP officer. After this decision of the Supreme Court, now the police will not take any immediate punitive action on any complaint lodged under Section 498. According to the

accused, and the main purpose of the committee will be to try mediation and settlement between the two parties, so that the relationship can be saved from breaking and misuse of the law can be prevented. This rule will apply to all those cases in which Section 498-I is also included along with other sections punishable with less than 10 years of imprisonment and no serious physical harm has been caused in the case. The Supreme Court gave this order while hearing a case related to a female IAS officer. The court has also ordered the female officer to apologize by publishing an

apology in the newspapers for harassing her husband and his relatives. Interestingly, these guidelines issued by the Allahabad High Court in 2022 were based on a decision of the Supreme Court itself in 2017 (Rajesh Sharma vs State of Uttar Pradesh). However, in 2018, the Supreme Court had struck down these guidelines in another case (Social Action for Human Rights vs Union of India), due to which the Family Welfare Committees became inactive. Now with this new decision on Tuesday, the mechanism of Family Welfare Committee has once again become effective across the country.

## Historic jump in Bihar's railway budget, 9 times increase in 11 years: Ashwini Vaishnav

**Gorakhpur,** Union Minister of Railways, Information and Broadcasting and Electronics and Information Technology Ashwini Vaishnav, while sharing detailed information about the development work being done under railways in Bihar in the Lok Sabha, said that under the leadership of Prime Minister Modi, Bihar has received historic benefits in the railway sector. He said that 11 years ago, the railway budget for Bihar was only Rs 1132 crore, which has been increased to Rs 10,000 crore by Prime Minister Modi. This nine-fold increase reflects the central government's deep



commitment to the aspirations and needs of Bihar. He said, "After all, these projects were started by the NDA government and have also been completed by the NDA government. It is clear from this that only the NDA can do justice to the people of Bihar. Shivhar-Sitamarhi

project got new momentum. Speaking on the Shivhar-Sitamarhi project during a discussion in the Lok Sabha, Union Railway Minister Vaishnav said that this is a very important project. The tender process has been completed for the bridge to be built on the Bagmati River,

which will connect Dekuli Dham Shivhar. An amount of Rs 262 crore has already been deposited for the land acquisition of this project and the work is progressing rapidly. Apart from this, Rs 557 crore has been sanctioned for the Sitamarhi-Shivhar new railway line project, and its work is also going on at a fast pace. The gift of Amrit Bharat trains Minister Vaishnav also said that various regions of Bihar have been connected with new Amrit Bharat trains, which have been started on major routes like Patna to Delhi, Darbhanga to Delhi, and Darbhanga to Bangalore.

## Opposition leaders are not allowed to speak in the House, alleges Priyanka Gandhi Vadra

**New Delhi,** Politics over the issue of Special Intensive Revision (SIR) of voter list in Bihar is not stopping. Congress MP and General Secretary Priyanka Gandhi Vadra has given a statement on this issue. She alleged that whenever opposition leaders want to speak in the House, they are not allowed to speak. Congress MP Priyanka Gandhi Vadra on Thursday spoke to the media in the Parliament premises and made serious allegations against the government. Priyanka Gandhi said, whenever opposition leaders want to speak, they are not allowed to speak. We have been demanding a discussion and they should agree to it. In the last session, I was surprised to see that the disruption starts from the ruling party. They used to choose a topic so that we react to it. Then there is an uproar and the House is adjourned. This is perfect for them. This is not the first time that an opposition leader has accused the government of not allowing him to speak in the House. Earlier, Leader of Opposition in Lok Sabha Rahul Gandhi had alleged that I am the leader of the opposition, but I am not being allowed to speak. This is a new approach. ## Flood threat in Delhi, Yamuna in spate, landslides in mountains cause devastation; Heavy rain alert across the country

**New Delhi,** Monsoon has taken a fierce form across the country, due to which life has been disrupted from North to South India. Yamuna river is flowing at the danger mark in the national capital Delhi, while torrential rains and landslides have caused havoc in the hilly states of Himachal and Uttarakhand. Flood-like conditions have arisen due to heavy rains in many states including Mumbai. The capital Delhi is facing the threat of flood. The water level of Yamuna has reached the danger mark due to continuous rise, due to which water has started entering many low lying areas. After the information of more water being released from Hathinikund



Barrage in Haryana, there is a possibility of the water level rising further. In view of this, the administration has issued orange and red alert in the affected areas and has advised people to move to safer places. The situation has gone out of control due to the continuous torrential rains in Himachal Pradesh in Mandi and NH-707 (Hatkoti to Paonta Sahib) in Sirmour are blocked

due to landslides at many places. Schools have been closed in both the states and the administration is engaged in relief and rescue work. Heavy rains have also created problems for people in Maharashtra's financial capital Mumbai. Traffic has been badly affected due to waterlogging on the roads. The Meteorological Department has issued a forecast of rain in many parts of the country for the next 24 hours. Coastal Karnataka, South Konkan, Goa, South Chhattisgarh, Telangana and Vidarbha may receive moderate to heavy rains. At the same time, Haryana, East Rajasthan, and Kerala are also expected to receive light to moderate rains at some places.

## ED raids companies linked to businessman Anil Ambani, action is going on in Mumbai

**Mumbai,** ED has raided the companies of famous businessman Anil Ambani. According to the information, this raid is being conducted in Mumbai. Let us tell you that State Bank of India had recently declared Anil Ambani a fraud. This action was taken on the basis of two FIRs of National Housing Bank, SEBI, National Financial Reporting Authority, Bank of Baroda and CBI. Searches are also being conducted in the premises of many senior officials of companies associated with Anil Ambani. According to the information, during the investigation, ED has found evidence that this was a well-planned conspiracy to embezzle public money. Many institutions, banks, shareholders and investors were defrauded in this. The promoters of Yes Bank are also under suspicion in this. There is suspicion of illegal manipulation and misuse of loans worth about Rs 3,000 crore taken from Yes Bank between 2017 and 2019. Let us tell



you recently the SSI had declared Anil Ambani as a fraud. Earlier this month, the loan account of Anil Ambani's company Reliance Communication got a big blow from the SSI. The SSI had sent show cause notices to the company in December 2023, March 2024 and September 2024. After reviewing the company's reply, the bank had said that Anil Ambani's company did not comply with the terms of its loan and did not give complete information about the irregularities in the operation of its accounts.

## Dhankar reached Rashtrapati Bhavan breaking protocol, had to wait for half an hour to submit his resignation

**New Delhi,** There was a political upheaval in the country when Vice President Jagdeep Dhankar suddenly resigned from his post on Monday. The surprising thing was that Dhankar broke the protocol and went straight to Rashtrapati Bhavan to submit his resignation to President Draupadi Murmu without any pre-scheduled program. There he had to wait for about half an hour to meet the President. Immediately after submitting his resignation, he made it public on social media and went to vacate his government residence. After this unexpected development, the layers of discomfort between him and the government have started to unfold. According to sources in Rashtrapati Bhavan, Dhankar suddenly reached Rashtrapati Bhavan at around 8:30 pm



on Monday night without any prior information. His arrival in this manner created an atmosphere of chaos there. Since he had no scheduled time to meet the President, the officials immediately informed the President about it. He had to wait for about half an hour in this process. As soon as the meeting

took place, Dhankar submitted his resignation to the President. After Dhankar's resignation, many stories of the strained relations between him and the government are now coming to the fore. It is being discussed that there were differences between him and the government on many issues. For example, it is being told that he insisted on meeting US Vice President JD Vance, who visited India in April. Not only this, recently he had also allegedly reprimanded Union Agriculture Minister Shivraj Singh Chouhan on a public platform regarding the issue of farmers, which made the government very uncomfortable. These incidents indicate that the confrontation between the two sides was brewing for a long time, which ultimately culminated in his resignation.
