पटना। बाद अनुमंडल के सम्यागढ़ थाने में आयोजित जनता दरबार में आज अचानक हंगामा हो गया। कुछ लोगों ने अंचलाधिकारी पर गोली मारने की धमकी देने का गंभीर आरोप लगाया। मामला कुंभकंठ में 20 बीघा जमीन को लेकर दो पक्षों के बीच चल हे विवाद से जुड़ा है। एक पक्ष के सुनील कुमार के लिए हे विवाद कुछ महीने पहले अचलाधिकारी अनुज कुमार के पास पहुंचा था।



सुनील कुमार का आरोप है कि सीओ ने बिना दस्तावेज जांचे दूसरे पक्ष के हक में फैसला सुना दिया। उनका कहना है कि जिसका जमीन पर कब्जा था, फैसला भी उसी के पक्ष में दिया गया। जब सुनील ने सीओ के फैसले का विवाद किया, तब पर धमकी देने का आरोप है। सुनील के अनुसार, सीओ ने कहा कि “अगर उसकी जगह मैं होता, तो गोली मार देता।” इस घटना के बाद दोनों पक्षों ने थाने में जमकर हंगामा किया। सुनील कुमार का यह भी आरोप है कि विपक्षी पुलिस की मदद से उनकी जमीन पर जबरदस्ती कब्जा करना चाहते हैं। हालांकि, जब सीओ अनुज कुमार से इस बारे में पूछा गया, तो उन्होंने किसी भी प्रकार की धमकी देने से इनकार कर दिया।

He said that all lawyers should establish their identity as the architect of justice. According to the former CJI, there is no shortcut to success. Especially the candidates studying law learn something new throughout their life. They are independent thinkers. Addressing the students in the law college, former CJI Chandrachud said that justice should come first for lawyers. If you want, then definitely take guidance from others, your thinking should be independent. He said that if the new generation learns something new and remains honest towards their duty, then there are many opportunities open for you in this field. Today, women are also joining superspecialty and technical branches. This change should also come in the field of law. Participation of women in law should also increase. Chandrachud said that many students come from small towns and rural areas. They not only make important contributions to law colleges but also weave new stories of success. For better practice, students studying law should be provided with library database. Seniors should support new lawyers in their initial days and help them financially.

Urban Heart Syndrome is growing rapidly among the youth

New Delhi: Urban Heart Syndrome is growing rapidly among the youth nowadays due to reasons like work pressure, stress, lack of sleep, lack of physical activity and excess of junk food. It is not a single disease, but a mixture of many problems, which affects the functioning of the heart. This syndrome is especially affecting people between the ages of 30 and 40, whose heart is no longer able to work with as much strength as it should. Symptoms of Urban Heart Syndrome include shortness of breath, fatigue, heaviness in the chest, irregular heartbeat and high blood pressure. Two smugglers arrested with 330 bottles of Nepali liquor

East Champaran, The Jitna police station of the district has arrested two liquor smugglers during a raid at two different places on a secret information during patrolling on Sunday morning. The police arrested a smuggler with 210 bottles of Nepali Kasturi liquor during a raid near Kodarkat Chowk. The arrested smuggler was identified as Lalbabu Rai, son of Laxman Rai, resident of Semri village of Lakhaura police station area and the other was identified as Dheraj Paswan, son of Bigul Paswan, resident of Pipra village of Darpa police station area. Rahul Gandhi should give a declaration or apologize for false allegations: Election Commission



New Delhi Congress MP Rahul Gandhi is constantly accusing the Election Commission of vote theft. Regarding this, the Election Commission of India once again strictly reiterated its response to his statement. The Commission said that Congress MP Rahul Gandhi should give a declaration as per the rules or apologize to the country for his false allegations. Earlier also, the Election Commission of India had termed the statement of the Leader of the Opposition as misleading. The ECI Fact Check said that during the preparation of the voter list in Lok Sabha 2024, hardly any appeal was filed by the Congress in all 36 states and union territories under Section 24 of the RP Act 1950. Many such allegations are being made by Rahul Gandhi and reported by the media, while he has never submitted any written complaint. In the past too, he has never personally sent a self-signed letter. According to the EC, for

example, he raised the Maharashtra issue in December 2024. Following this, a lawyer of the All India Congress Committee wrote to the ECI. Our reply is publicly available on the ECI website on December 24, 2024. Yet Rahul Gandhi claims that the EC never responded. Election Commission Fact Check had posted on social media platform X that the Congress' plea to provide machine readable voter list was rejected by the Supreme Court in Kamal Nath vs Election Commission, 2019. Any aggrieved candidate can file

an election petition (EP) to challenge his election in the concerned High Court within 45 days. He said that if an EP is filed, the CCTV footage is preserved. Otherwise, it serves no purpose, unless someone intends to violate the privacy of the voter. For example, reviewing CCTV footage of 1 lakh polling stations will take 1 lakh days, i.e. about 273 years, and it is unlikely to lead to any legal consequences. If Rahul Gandhi believes in his analysis and believes that his allegations against election officials are true, he should have no problem in filing claims and objections against specific voters and signing a declaration or affidavit as per Rule 20(3)(b) of the Registration of Voters Rules, 1960. If Rahul Gandhi does not sign the declaration, it will mean that he does not believe in his analysis and the resulting conclusions and is making absurd allegations. In such a case, he should apologize to the nation.

Encounter started in Kishtwar, Jammu and Kashmir, Army surrounded the area; Information of two terrorists hiding Jammu



Jammu An encounter broke out between the Indian Army and terrorists in the Dul area of Kishtwar district of Jammu and Kashmir on Sunday morning. The operation of Indian security forces against the terrorists is still going on. The White Knight Corps of the Indian Army posted on the social media platform 'X' and informed about the operation of the Indian security forces against the terrorists. He wrote, during an intelligence-based operation, alert Indian Army soldiers encountered terrorists in the Dul area of Kishtwar on the morning of 10 August 2025, after which firing took place. The operation is still going

on. Let us tell you that the Indian Army is fully alert in the valley. Earlier on Friday late night, the anti-terrorism operation going on in the Akhal Devsar forest area of Kullu district entered its 10th day. A local civilian has been killed in this. Two army personnel were martyred in this operation and four others were

PM Modi flagged off three Vande Bharat trains, laid the foundation stone of new metro line



Bengaluru, PM Narendra Modi reached Karnataka on Sunday. Here PM Modi flagged off three Vande Bharat trains from KSR Railway Station. Along with this, PM Modi also laid the foundation stone of the new route of Bangalore Metro. The three Vande Bharat trains he flagged off include trains from Bengaluru to Belgaum, Amritsar to Katra and Nagpur (Ajni) to Pune. These high-speed trains will significantly enhance regional connectivity. Will reduce travel time and give passengers a world-class travel experience.

According to media reports, after flagging off the Vande Bharat trains, PM Modi also inaugurated the 19 km long Yellow Line of Bangalore Metro. The line runs from RV Road (Ragigudda) to Bommasandra and has been built at a cost of around Rs

7,160 crore. The line has 16 stations and connects major residential, commercial and industrial areas of the city. With the opening of this line, Bengaluru's metro network has grown to over 96 km, providing convenience to lakhs of commuters.

During his Bengaluru visit, PM Modi

also laid the foundation stone for the third phase of the metro project. The project will cost over Rs 15,610 crore and will add over 44 km of elevated tracks and 31 new stations. It is expected to further strengthen the city's public transport and help reduce traffic congestion.


Good news for railway passengers on festivals, 20 percent discount on round trip tickets



New Delhi, Indian Railways has announced a new facility for passengers, under which 20 percent discount will be given on the base fare of the return journey if the tickets for coming and going are booked together. This 'Round Trip Package' scheme is currently being implemented on an experimental basis, so that its impact and passenger response can be assessed. This round trip package scheme will be started from August 14. Under this, passengers will have to book the ticket for the first journey for the date between October 13 to October 26, 2025. The return ticket can be booked through the 'Connecting Journey Feature' for the benefit of economical travel.

date between November 17 to December 1, 2025. According to the railways, the discount will be given only if the tickets on both sides are confirmed and in the name of the same passenger. Advance reservation period will not be applicable for booking return tickets. This discount will be given only on the base fare of the return journey. The railways believe that this scheme will enable better use of trains on both sides during festivals and passengers will also get the benefit of economical travel.
